- **THANK YOU** for considering a GFCRD Plan at Ocean Acres C.C.
- Plan choices at OACC are *Simple and Straightforward!!* Purchase now, save, and avoid the Green Fee when you play golf.
- You can choose between a 5-Day or a 7-Day plan. If you like to play golf as much as we do, then you will likely want to consider adding a cart rental option.
- New for the 2017 Golf Season is the *Performance Plan*. Throughout the year, the golf shop publishes the cost for a green fee and cart rental, otherwise known as a Ride 'n Play fee. This fee changes throughout the day and the time of year. If you choose to become a Performance Planholder, you will be guaranteed not to pay more than 50% of the published Open Ride 'n Play fee. For example, if the cost to play golf with a cart at Open is \$45, your fee as a Performance Planholder would be \$22.50 and it would not be more than that for the entirety of that day. If the cost, due to a promotional offer or tiered pricing, is lower than \$22.50, in this example, then you would only be required to pay that lower fee. This new plan is suited for the golfer who doesn't have the time to commit to a heavier golf play schedule, but enjoys playing somewhat frequently.
- OACC also has a plan for the Junior Golfer that needs a low cost option while learning the game. Additionally, the parent, guardian or close relative of the Junior golfer is considered a "Performance" Planholder while playing golf w/ the Junior Planholder.
- OACC offers the USGA GHIN Handicap Computation Service. The Active Season in NJ is from April 1 through October 31, each year. Shortly before the beginning of

the 2017 Active Season, the Handicap Computation Applications will be made available.

- Although a GFCRD Plan Term runs from 3/1/17 to 2/28/18\*, you can begin playing golf as a Planholder as soon as we receive your completed application and payment.
- While at OACC, you can enjoy the complete food and beverage amenities. In "The 19th Hole", our sports bar, there is plenty on the menu, either before your round, during or after; breakfast, lunch or dinner. If you miss the opportunity before you tee off, you can stop by after you have finished No. 9 on your way to the island green, picturesque, Hole 10. Out roving about, the courtesy cart will be bringing that needed beverage and/or snack. When you finish your round you might enjoy a beverage while sitting lake side at Holiday Lake.
- If you find yourself in the position of coordinating a Golf Outing/Tournament, small or large, Ocean Acres has you covered with Complete Banquet & Catering facilities.
- If you act quickly, you can take advantage of some Early Bird specials. If you choose either of the Individual Plans, with or without the cart rental option, you can **deduct 15%** from the purchase price if the purchase is made by **10/15/16**. If you miss that date, make your purchase by **11/19/16**, and **deduct 10%**. If you couldn't do so by then, there are still savings through **12/31/16--deduct 5%**. There are savings for the Performance Plan as well. Make your purchase by **10/31/16**, and **deduct 10%**, otherwise, the opportunity to **deduct 5%** is still in play through **12/31/16**.

- On the following page is the Downloadable Application Form. We have squeezed quite a bit of information on this single page. If you would prefer, there exists an Application Form in a more Brochure-like format available at the club. Please contact the Golf Shop and request one.
- We certainly would welcome your visit to the club, so please consider stopping by if you have questions or would like to purchase in person.
- If you choose to use the Downloadable Application Form, it is very simple, and the Easy Instructions are right at the top so you won't miss it.
- Although it may look complicated to determine what the cost will be, it really isn't. There are only a couple of things that you need to know: First, decide which plan you want, 5-Day, 7-Day or Junior or Performance. If you believe that you are going to play enough golf to pre-pay your cart rentals for the entire term, then add the cost of the Cart Rental Option. That's really all there is to it.
- Of course, as we've already told you, there are still more savings to be had. Yet, that depends on when you purchase. If you are eligible to take advantage of Early Bird pricing, take your calculated cost and apply the appropriate deductions.
- All applicable taxes will be charged. The NJ Sales Tax rate of 7 percent applies to golf cart rentals. All required sales tax has been included in the GFCRD Plan fees.
- If you are contemplating a Cart Rental Option, the following should help you make an educated guess as to how much you may pay for cart rentals throughout the year, if you pay as you go.

The Performance Plan is a 12-month plan that commences on 10/1/16 and is valid until 9/30/17. All GFCRD Plans are not sold pro rata. Ocean Acres Country Club retains the right to revoke GFCRD Plan rights if Planholder violates any of the agreed rules and regulations as stated on application form and found elsewhere at the Ocean Acres Country Club property as well as its web site.

### II. PLAN SELECTION

**ALL PLANS DO NOT INCLUDE THE FEE FOR A GHIN HANDICAP ACCOUNT; THE GHIN COMPUTATION SERVICE MAY BE PURCHASED SEPARATELY**

- Individual** *Golfer may reserve a round of golf for any day, required only to pay for powered cart rental when desired and/or required* **\$1375.00\***
- Weekday Individual** *Golfer may reserve a round of golf for any weekday (Monday thru Friday, excluding Designated Holidays), required only to pay for powered cart rental when desired and/or required* **\$975.00\***
- Junior** *Junior golfer (between ages 9 and 17, inclusively), may reserve a round of golf for any weekday (Monday thru Friday, excluding Designated Holidays), at any time of day, and for any weekend day (Saturday, Sunday) or holiday after 10:00 AM, required only to pay for powered cart rental when permitted and/or required (if a junior golfer does not have a driver's license, when a powered cart is required, a trail fee will be charged in lieu of the powered cart rental); additionally, parent, guardian, or close relative of Junior golfer is considered a "Performance" Planholder while playing golf w/ the Junior Planholder; cart rental option is not applicable to this plan* **\$350.00**
- Performance** *Golfer may reserve a round of golf for any day, required only to pay no more than 50% of the published Open Ride 'n Play fee on the day of play; cart rental option is not applicable to this plan* **\$595.00\*\***
- Cart Rental Option** *A pre-paid cart rental available to either type of Individual Planholder; may only be used in conjunction with a single round of golf per day* **\$1345.00\***

PLEASE SELECT ONLY ONE PLAN TYPE; SELECT THE CART RENTAL OPTION IF DESIRED; ALL GFCRD PLANS ARE NOT VALID DURING SHOTGUN OUTINGS/TOURNAMENTS

\* Purchase a qualifying 2017 GFCRD Plan and pay in full by 10/15/16, reduce total fee by 15%; by 11/19/16, reduce fee by 10%; by 12/31/16, reduce fee by 5%.

\*\* Purchase a 2017 Performance Plan and pay in full by 10/31/16, reduce total fee by 10%; by 12/31/16, reduce fee by 5%.

Δ Age qualifications must be met when observing June 1, 2017. For example, an 8 year old may purchase a Junior Plan provided that by June 1, 2017 he/she will be 9 years old. Conversely, a 17 year old that will be 18 years old as of June 1, 2017 may not purchase a Junior Plan.

### OCEAN ACRES COUNTRY CLUB 2017 RULES & REGULATIONS

- Mandatory Foursome Rule : Starting time reservations must be made for four golfers. Payment obligation must be rendered for all four golfers. If less than the four reserved starting times are committed, the starting time for the group may be delayed or forfeited with other available golfers.
- Starting Time Policy : Upon committing to a starting time reservation, the individual(s) reserving the starting time must be responsible for all Unpaid Reserved Starting Time Green Fees and the appropriate number of Powered Golf Cart Rentals.
- The Mandatory Cart Rule : Singles or Twosomes are required to rent One Powered Golf Cart; Threesomes or Foursomes are required to rent Two Powered Golf Carts.
- Cart Rental Limitations : No more than one cart may be rented for any two golfers. If applicable, both occupants must acknowledge & sign for cart rental. Golf cart drivers must have and may be requested to present a valid motor vehicle driver's license.
- Walking ILO Cart Rule : A special Trail Fee is available when carts are mandatory that allows the golfer the ability to walk ILO renting a Powered Golf Cart. You Must Check with Club Management to verify if this rule is in effect.

- The "Tee Sheet" will open for bookings 14 days prior to respective date. A Planholder has the right to reserve, one round of golf per day, based on current availability regardless of individual who reserves the aforementioned round of golf.
- All GFCRD Plans, except the Performance Plan, entitle the planholder to one non-paid round of golf per day. If Planholder desires to play an additional non-paid round of golf on the same day, approval from Club Management is necessary. The Performance Planholder is not restricted to the number of rounds per day.
- Planholders playing in any Shotgun Format Outing/Tournament other than OACC hosted events must pay a Green Fee and Cart Rental.
- Planholders may be required to provide and maintain a valid credit card, on file, to be used for collection of delinquent financial obligations.
- Any Planholder that incurs Green Fee and/or Cart Rental charges because of "No Shows" and does not take care of his/her financial obligation will force his/her GFCRD Plan to be placed under review by the All-Fore Club board and risk suspension or cancellation of his/her GFCRD Plan.
- The Mandatory Foursome Rule may be put into effect from time to time as the OACC Golf Shop deems appropriate.
- No fivesomes are allowed without advanced notice and authorization from OACC Management; advanced notice is only required during the months of May, June, July, August, and September, however, authorization from OACC Management is still required.
- The Mandatory Cart Rule is in effect on weekends and holidays until 1:00 pm from April 1, 2017 to October 31, 2017, on weekdays until 1:00 pm from July 1, 2017 to August 31, 2017, and on weekdays until 11:00 am for the months of May, June and September.
- Cart rentals are not included in basic GFCRD Plans and will be charged at time of rental. Plan Options which include cart rentals afford the Planholder an option to pre-pay for cart rentals but do not relieve Planholder of any policies, rules, and/or regulations which govern cart rentals.
- Planholders may be issued a Planholder Card and may be required to present it along with a form of identification at the Golf Shop Desk prior to Starting Time. If required, and a Planholder Card is not presented, a Green Fee will be charged.
- Under certain weather conditions, golf carts may be required to remain on the cart path. This Cart Paths Only rule may be in effect for any part of the golf course. All golfers are expected to adhere to this rule and leave the golf cart on an appropriate cart path, when in effect.
- A person must be at least 8 years old to ride in a powered golf cart. A person may only drive a powered golf cart with a valid driver's license.
- A golfer must be at least 6 years old to play golf at OACC. Additionally, a golfer younger than 13 years old is required to do so with adult supervision.
- Food, alcoholic or non-alcoholic beverages (with the exception of bottled water), coolers or cooler-like containers are not permitted to be brought onto the OACC property unless prior arrangements have been made with OACC Management.
- Under all circumstances, strict attention must be given to OACC personnel, specifically The Ranger. If resistance is encountered you will be requested to leave; and if you do not comply, you will be escorted from the premises by local and/or state police.
- Any misconduct with respect to behavior while on the premises of the golf course that results in a police action or any type of altercation with other golfers, patrons of the club, and/or OACC staff will result in an automatic suspension of GFCRD Plan and upon further review may result in termination of GFCRD Plan without any remuneration.

### III. TERMS & AGREEMENT

By signing this agreement, you acknowledge complete understanding of the plan that you have chosen and hereby agree to abide by *The Rules of the United States Golf Association* and *The Ocean Acres Country Club Rules & Regulations* (subject to modification from time to time as OACC deems necessary). It is also understood that any GFCRD Plan, once purchased, is non-transferable. Cancellation/Revocation and any respective refund will be determined at the sole discretion of OACC. Once you have submitted a signed application, along with correct payment, your GFCRD Plan will become effective and expire as stated herein.
